RESERVATION & DEPOSIT

To confirm a date and time for the event, a \$00.00 deposit is required. The deposit will be applied to the total charges for your function. The deposit is non-refundable.

GUARANTEED NUMBER OF GUESTS

A final commitment to the guaranteed number of players must be received 7 days prior to the date of the event. If the day of the If a group wishes to add more players past the 7 day point, notify via email as soon as possible.

SPONSORS/VENDORS

Limited to 6 per Outing. Must be notified one month in advanced as to how Sponsors/Vendors will be attending. A \$100 non-refundable cart rental fee will be charged to Outing on final invoice. They will need to provide their own needs; chairs and tables, etc. Outside food or beverages are not allowed. All food and beverages must be purchased with Mystic Creek Golf Course. Prior arrangements for purchasing any food or beverages is required.

DRESS CODE

Proper golf attire is required at all times. Mystic Creek Golf Course has adopted a spikeless policy. Please inform members of the group of the entire Dress Code Policy so as to prevent any confusion on the day of the event.

PAIRINGS & PACE

In order for Mystic Creek Golf Course to provide an organized tournament for your group, it is required that a list of pairings be submitted no later than 3 days before the date of play. This allows sufficient time to prepare the cart signs, score sheets, and proximity markers, etc... Also, in the spirit of "Keeping Pace," each group will be encouraged to complete their round within 4 ½ hours. After 6 hours, groups will be forfeiting remaining holes and will be asked to return golf cart to the Club House immediately.

RAIN CHECK POLICY

In the event that the golf course is deemed unplayable due to inclement weather, such as thunder and lightning (storm) that may cause damage to the individuals or course, Mystic Creek Golf Course reserves the right to close the course. If there is a storm, a decision will be made by the Golf Course Superintendent, in conjunction with the Golf Professional & General Manager as to when play may resume. The group will still be held responsible for food and beverage charges. In the case of inclement weather, where golf is still permitted, such as light rain, high winds and cold temperatures, golfers are expected to play. Mystic Creek Golf Course will make the final decision in declaring a rainout.

LOSS OR DAMAGE

The group representative will be held responsible for reimbursement to Mystic Creek Golf Course for the cost to repair damages to any property or adjoining properties caused by a guest or themselves. Mystic Creek Golf Course is not responsible for articles that are lost, stolen, or damaged.

FOOD & BEVERAGE REQUIREMENTS

All food and beverage provided for outing MUST be purchased with Mystic Creek Golf Course. Food and beverages not consumed are not permitted to leave the premises. Any outside food or beverages will be confiscated if found on the premise. The Michigan Liquor Control Commission directly forbids any alcoholic beverage to be brought or taken from the premises, failure to adhere to will result in confiscation of the product. Course Beverage Carts are CASH only. Guests who are visibly intoxicated or minors will not be served alcoholic beverages. Dietary needs and Vegetarian request will be provided with Chefs choice meal, any request will need to be communicated prior to event.
